#### Code of Conduct Tank Services Valley B.V.



### 1. Purpose and Scope

This Code of Conduct describes the standards, values, and rules of conduct applicable to all employees, contractors, suppliers, and partners of Tank Services Valley (hereinafter referred to as TSV).

- Regular inspections and quality measurements are mandatory and must be recorded.

## 4. Responsible Transport and Logistics

- Vehicles used for food transport must be clean, well-maintained, and suitable for their specific purpose.
- Drivers are required to:
  - o Follow traffic rules and drive safely
  - o Monitor and record temperature for perishable products
  - o Report incidents, delays, or deviations immediately
- Cargo must be properly secured and protected from contamination.

  - o Fraud or falsification of data
  - o Conflicts of interest

### 6. Labor Rights and Workplace Behavior

- TSV ensures a safe, inclusive, and respectful work environment.
- Discrimination or harassment based on race, gender, age, religion, nationality, or any other protected status is prohibited.
- Management and employees are expected to:
  - o Treat colleagues, suppliers, and customers with respect
  - o Refrain from any form of violence, bullying, or abuse at work

#### 7. Health, Safety, and Environment

- The well-being and safety of our employees, suppliers, and customers are a priority.
  Everyone must:
  - o Comply with safety regulations
  - o Immediately report unsafe situations or accidents
  - o Use personal protective equipment (PPE) correctly
- We strive to minimize our ecological footprint by:
  - o Reducing waste and emissions
  - o Conserving energy and water
  - o Efficient transport and route planning

## 8. Confidentiality and Data Protection

- Confidential information about the company, customers, and suppliers is protected from unauthorized access or disclosure.
- Employees are required to:
  - o Use IT systems safely and professionally
  - o Follow company-specific guidelines for passwords and data management
